## **COMMITTEE REPORTS**

### **Dance Committee:** David Rodgers, Chair Janis Grimes, Liaison

Dance Committee Chairman David Rodgers presented a proposal to the board asking for funding to pay for a series of workshops for NVSC instructors on how to teach. He was accompanied by Joan McKinney. The board listened and thanked David for his comprehensive presentation on behalf of the committee.

There has been a great deal of time and energy spent by the board, both in meetings and during personal time, concerning the request for funding from the Dance Committee. The board carefully and respectfully considered each request.

Regarding the request for funding for nametags for dance instructors, the board's policy is that the Dance Committee chairman already has the authority to spend up to \$150.00 for incidental expenses, as needed. In this case, the board concluded that \$150.00 has been spent for a number of nametags, but if needed a separate receipt can be submitted for the remainder of the nametags purchased and David can be reimbursed for that additional amount (\$41.10).

After another extensive and open re-discussion of the requests originally presented by the Dance Committee, the board decided to let the original vote stand. The consensus was that the club is run by the efforts of many members who volunteer. All members (with the exception of the deejays, who are paid employees) donate their time, expertise, talent, and energy to benefit the club with no expectation of payment for services.
