Dance Committee: Vaughn Royal, Liaison – Tim Farris – No report.

Social Committee: David and Nancy Guilliams, Sandra Traylor, Sam Wray, Barbara Jones, Paul & Sue Young, and Jeanne Potter – Sue gave a report on the Paradise Springs Winery in Clifton as a possible site for the picnic. There would be a charge of \$50 per hour for the rental of the barn, and while we would be able to bring in all of our own food, no other alcoholic beverages would be allowed. Sue also checked out the Moose Lodge, but you would have to be a member to use the facility. Jeanne mentioned that there are two other places that she will check out and report on.

Charity & Fundraising: Kathy Miller & Nancy Cox Co-Chairs – No report.

Public Relations: Barry Newman – Barry commented that he has flyers announcing the Fast Eddie's Sunday Social that he will pass out at Rene's on Wednesday, and will post on our web site. He will also contact all of the clubs on his network about the Mini Shag Classic on July 23, and possibly trying to get an ad in the Fairfax Times.
