# Special Board of Directors Meeting June 26, 2012

- I. Call to Order: The meeting was called to order by President Dave Bushey at 8:32pm; meeting was held at Icon's. President Dave Bushey, Vice President Sue Young, Secretary Angie Bushey, Directors Sharon Geyer, Mark Hendrickson, Tim Farris and Jeanne Potter present; quorum established.
- II. Purpose of Special Board meeting: Motion was made by Mark Hendrickson to dispense with all other Customary business except for the three special items of business, motion carried.
  - A. Cannot dance at Icon's next week, Tuesday July 3. Dave was notified Icon's has a private event scheduled next Tuesday. Motion made by Tim Farris NVSC dance next week at Grevey's in Falls Church, motion carried. Dave will call Grevey's tomorrow.
  - B. Results of survey polling NVSC membership which night they want to dance, Tuesday or Wednesday. Survey link was sent via Hello Shaggers. Single question posed do you want to dance Tuesday night-Wednesday night or does it matter which night? Results were 110 responses, Tuesday night 13%, Wednesday 57%, doesn't matter 30%. Sue Young made the motion NVSC will dance on Wednesday night at Icon's beginning Wednesday August 1, 2012.
  - C. Condition of the dance floor at Icon's is consistently bad. NVSC has tried powder, Dance Ice, tonight's experiment was oatmeal (suggested by member, Clarendon Ballroom uses oatmeal on the floor). Sue has received bids from six different floor people, with greatly varying plans and costs. There are a couple that seem to be more in line with NVSC budget and thinking for upkeep; Sue will contact them for more details and specifics. Motion made by Sharon Geyer that NVSC hire a professional floor person to clean the floor to start and that the floor be kept up by NVSC on ongoing and regular basis, motion carried. Sue will present the final bids at regular Board meeting July 2, and floor will be cleaned in preparation for the Classic kickoff party (Friday, July 20).
