



**Minutes
Board of Directors Meeting
August 6, 2012**

- I. Call to Order:** The meeting was called to order by President Dave Bushey at 7:31pm; meeting was held in the law offices of Surovell, Isaacs, Petersen & Levy PLC. President Dave Bushey, Treasurer Kathy Norris, Secretary Angie Bushey, Directors Jeanne Potter, Mark Hendrickson, Tim Farris, Sharon Geyer and Jack Jones present, quorum established.
- II. Reading and Consent of Prior Month Minutes:** Motion made by Sharon Geyer to approve the Minutes of the July Board of Directors as presented, seconded by Tim Farris, motion carried.
- III. Treasurer's Report:** Kathy reviewed Classic Expenses, estimated and actual to date, and Classic estimated income amounts to date, as shown on the report detail. Deposit for the Jackie and Charlie dance Feb 23 2013 has been made to Ft Myer, and the club purchased the iPod docking station, all expenses in July. Kathy has gotten the 'actual' membership numbers to replace her estimated numbers of recent months, shows decline over the past two and a half years from high of 261 to current of 211. Last year's Board analyzed causes of decline, found: 1) members moved out of the area, 2) members cited health problems, 3) new members not renewing after first year. Tim will get the information to Kathy; she will do a current analysis. Dave asked that the names of members with expired memberships be part of the monthly reports to the Board. Motion made by Tim Farris to accept the Treasurer's Report of July as presented, seconded by Jeanne Potter, motion carried. Housekeeping: Kathy has re-stated figures to express SOS cards as outstanding liability (in particular, a \$270 adjustment made to reflect cards that were sold in prior year) and adjustments made to membership figures in reports of May and June. Motion made by Tim Farris that the revised financial statements be accepted as presented, seconded by Mark Hendrickson, motion carried.

VI. Old Business

- A. Update on Icon's floor – discussion of NVSC purchasing a portable dance floor that can be used on top of existing floor space at Icons. It would require setting up and taking down each week, exclusively used by NVSC. Dave unboxed samples of three snap together tiles for everyone to examine. Kathy had contacted additional companies and priced using 25x30=750SqFt, approximately \$5000. Further discussion. Dave will work with Kathy to get more information and purchase of dance floor will be put on agenda for General membership meeting in August.
- B. Sarbanes-Oxley Policies - Whistleblower amendment – Mark Hendrickson presented two versions, motion made by Kathy Norris to accept Whistleblower Policy, version A, seconded by Jeanne Potter, motion carried.

Dave has talked with Richmond Shag Club, RSC is willing to share server capacity and cost at their Homestead platform; RSC uses Benchmark for their blast emails, and can host more than one “campaign” list.
