



## Minutes

### Board of Directors Meeting

April 1, 2013

**I. Call to Order:** The meeting was called to order by President Dave Bushey at 7:32 pm. The meeting was held in the law offices of Allred, Bacon, Halfhill & Young. Present were President Dave Bushey, Vice President Sue Young, Treasurer Kathy Norris, Secretary Angie Bushey, Directors Mark Henderickson, Fran Mong, Donna Romito and Ed Hamer.

**II. Reading and Consent of Prior Month Minutes:** Motion made by Mark Hendrickson to 'accept by consent' the Minutes of the March Board of Directors meeting as amended, seconded by Sue Young; motion carried. Motion made by Kathy Norris to approve the Minutes of the Special Board of Directors Meeting of March 11, 2013 as presented, seconded by Mark Hendrickson, motion carried. Motion made by Sue Young that this Board of Directors, for purposes of acknowledging that Board meetings were held, business conducted, and completeness of prior years history, to accept the information presented as Minutes of Board of Directors Meetings of May 9, 2011, June 7, 2011, and October 3, 2011; seconded by Mark Hendrickson; motion carried.

**III. Treasurer's Report:** Kathy Norris reviewed the Treasurer's Reports: note the balance available has had significant change, \$619 participation fee to National Fast Dance Association and \$1500 deposit for the hotel for the Classic. Membership number remains constant with five new members and five non-renewals. Final numbers for Charlie/Jackie workshops and dance reflect profit of \$62.66, however with deposit of \$100 paid, results in net loss of \$37. There being no further discussion, the Treasurer's Report will be filed for audit.
