



**Board of Director's Meeting  
10 Mar 2014**

- I. **Call to Order:** The meeting was called to order by President Dave Bushey at 7:37 p.m. at the law offices of Allred, Bacon, Halfhill & Young, PLLC. Present were President Dave Bushey, Vice President Ed Hamer, Secretary Bonnie Arms, Directors-at Large Fran Mong, Ken Morford, Jason Potter, and Sue Young. Not present: Director-at-Large Pamela Alfano and Treasurer Mark Hendrickson.
- II. **Reading and Consent of Prior Month's Minutes:** The 03 Jan 2014 Board of Director's Meeting Minutes were read. Jason Potter made a motion that they be approved as presented.
