

MEETING OF THE BOARD OF DIRECTORS January 9, 2017

- I. Call to Order: The meeting was called to order by Vice-President Bonnie Arms at 7:32 p.m. in the law offices of Allred, Bacon, Halfhill & Young, PC. - **II. Reading and Consent of Prior Month Minutes:** Approved as amended.
