NVSC Events at Ft. Myer....

As many of you may know, we are planning our annual Charlie & Jackie workshop and party for January 5, 2002. Both the workshop and dance are scheduled to be held at the Ft. Myer Community Center which is a wonderful facility that we have used many times before. Unfortunately, due to the Sept. 11th attacks, all military installations are performing at a heightened level of security. Ft. Myer is certainly no exception. In order for our club members to attend functions at the community center on Ft. Myer we must now **PROVIDE A LIST** of those planning to attend any events held on the post. This includes a list for the workshop and a separate list for the dance. If you are planning to attend **EITHER** of these events you **MUST LET US KNOW NOW** so that we can compile the lists and submit them to the post in a timely fashion.

The day of the workshop and party: When you reach the gate at Ft. Myer, if you have DOD ID cards and DOD automobile stickers on the front windshield of your car, you will have your ID cards checked to confirm that the IDs match the occupants. If you do not have a DOD ID you will have to show a drivers license/picture ID. Your name will be checked against the list provided by the club, and your car **WILL BE INSPECTED** inside and out after the occupants are asked to get out of the car. Please do not take any unnecessary items (luggage, golf clubs, etc.) onto the post as this may increase the amount of time spent by the MPs searching your vehicle.

If you do not provide NVSC your name early enough to get on the list submitted by the club you will likely have a very difficult time getting on the installation or may be turned away at the gate. Please remember too that this is **SERIOUS BUSINESS** and the Ft. Myer MPs are not likely to take any guff off anyone. Once your car pulls onto the installation, you are on federal property and subject to federal law.
